Examiner: ANAC Inspector or Senior Examiner.

ANAC approval: MANDATORY (check [webportal](#) or *e-mail*, as applicable).

Licence endorsement: Not applicable.

Exam report: MANDATORY up to 15 days after planned date (ANAC Examiners: [webportal](#); NON-ANAC Examiners: [e-mail](#)).

Filling instructions

SECTION A: Self-explanatory.

SECTION B.1: Select appropriate option depending on the purpose of the Examiner AoC.

SECTION B.3: Fill the flight or FSTD session details in line 1. In case the exam is conducted in more than one session, use line 2 for the 2nd session. Further sessions use Section C.

SECTION B.4: The examiner applicant shall pass all applicable items/sections 1,2 & 3 - grade **PASS**.

A fail in one or more items will require the examiner applicant to take the entire AoCE again - grade **FAIL**.

SECTION B.5: Self-explanatory.

⁽¹⁾ **In case of an AoCE for revalidation of an Examiner Certificate and a Fail is obtained:** the examiner applicant shall be informed and that in accordance with the Regulations, (s)he may not exercise the privileges of the Certificate, until a PASS in a new AoCE is achieved.

If the examiner applicant refuses to sign, the Inspector/senior examiner shall record the fact in Section C - "*Remarks/Overall Comments/Reasons for Failure*". ANAC shall be informed with undue delay.
