




MST.028 - Member States to establish and maintain a State Plan for Aviation Safety (SPAS)

- ➤ Objective: to identify main safety risks affecting States national civil aviation safety system and set out necessary actions to mitigate those risks
- >SPAS to have a link with EPAS
- ➤ Target: mature SPAS established by 2020



SSp assessment

Reportar 2 vezes/ano

- ➤ What are your major safety concerns and how do they substantiate their choice?
- ➤ Has the Organization been exposed to this type of scenarios in the last semester? If so, how many occurrences did take place? How many of those were considered high risk events?
- ➤ What are the 3 main factors that contributed to the risk?
- ➤ Which precursor events are being monitored from those identified in the Appendix 2 to SSp or others internally identified?
- ➤ How do you monitor and measure the effective implementation and performance of your mitigation actions for this issue?
- ➤ How do you share knowledge and lessons learned in your organization about this issue?

Managing safety (organizational structures, accountabilities, policies and procedures)

- ➤ Identification of aviation safety hazards
- > Evaluation of associated risks
- > Taking actions to mitigate the risk
- ➤ Verify their effectiveness
